Cyprus Friendship Program (CFP) promotes peace and understanding in Cyprus by bringing together teenagers from both sides of the divide with future leadership potential, encouraging lifelong friendships among them, and extending these friendships to their friends and families.

Cyprus Friendship Program (CFP) provides Cypriot teens, paired bi-communally, with a month-long living experience with U.S. host families in the United States. In 2014, CFP funded 34 teen pairs, i.e. 68 students, in five areas (Atlanta, GA; DC/MD; DC/VA; NH; and Portland, OR/SW Washington). Almost all of CFP's expenses are related to the travel and insurance costs for the teen pairs.

With the inclusion of the 2014 teens, CFP has paired and trained 284 Cypriot teens in the United States.

While in the U.S., the CFP teen pairs experience group workshops within their areas on conflict resolution, environmental issues, team building and community service. These activities focus the students on issues they share in common rather than issues that divide. Each area of the country uses its uniqueness to teach the lesson of reconciliation, e.g. civil war and civil rights movement in Atlanta, native American tribes surrounding Portland, Congressional visits in DC, environmental movement in NH.
