Cyprus Friendship Program (CFP) provides Cypriot teens, paired bi-communally, with a month-long living experience with U.S. host families in the United States. In 2016, CFP funded 34 teen pairs, i.e. 68 students, in five areas (DC/MD; DC/VA; SF; NH; and Portland, OR/SW Washington). Almost all of CFP's expenses are related to the travel and insurance costs for the teen pairs.

With the inclusion of the 2016 teens, CFP has paired and trained 406 Cypriot teens in the United States.

While in the U.S., the CFP teen pairs experience group workshops within their areas on conflict resolution, environmental issues, team building and community service. These activities focus the students on issues they share in common rather than issues that divide. Each area of the country uses its uniqueness to teach the lesson of reconciliation.
